(a) a statement in writing signed by the Petroleum Superintendent for the City of Corpus Christi setting forth the circumstances giving rise to the draft, or a statement of the Permittee's failure to furnish proof of renewal or replacement of this Irrevocable Letter of Credit not less than thirty (30) days prior to its expiration;(b) a properly drawn draft in the amount not to exceed the face value of this Irrevocable Letter of Credit; and (c) this original Irrevocable Letter of Credit.

It is a condition of this Irrevocable Letter of Credit that it shall be automatically extended without amendment for an additional period of one year from the current expiration date and each future expiration date, unless and until the City of Corpus Christi, Beneficiary, has been notified by Issuer in writing by registered mail or overnight courier, not less than (90) days before the expiration date that Issuer elects not to renew this Irrevocable Letter of Credit.

Furthermore, this Irrevocable Letter of Credit cannot be amended except with the written concurrence of Issuer, the Applicant, and Beneficiary.

This Irrevocable Letter of Credit is subject to and governed by the Institute for International Banking Law and Practice's, International Standby Practices, ICC Publication No. 590 (The "ISP98"), or other ICC publication applicable, to the extent not inconsistent with the laws of the State of Texas and more particularly with the provisions of Chapter 5 of the Texas Business and Commerce Code currently in effect. In the event of any conflict, the laws of the State of Texas will control, without regard to principles of Conflict of Laws.
