**DEFENDANT’S AFFIDAVIT AND REQUEST FOR A DRIVING SAFETY COURSE**

I, above named Defendant, waive my right to a jury trial and pled **NO CONTEST** to the offense of \_\_\_\_\_ and request to take a driving safety course. **I UNDERSTAND AND AGREE TO THE FOLLOWING CONDITIONS AND SWEAR UNDER PENALTY OF PERJURY THAT THEY ARE TRUE:**

1. I possess a valid **TEXAS driver’s license or permit** (or proof that I am a member or the spouse or dependent child of a member of the U.S. military forces serving on active duty) and must present this proof with my request to take a driving safety course.
2. I understand that I must present the Court with proof of **financial responsibility** (automobile liability insurance) with my request to take a driving safety course.
3. I must pay a reimbursement fee of \$10.00 plus the State assessed court costs and fees, for a total of **\$144.00 or \$169.00 for speeding in a school zone citation**, to comply with my Interim Judgment and Order to Comply. You may pay online at [www.municipalonlinepayments.com](http://www.municipalonlinepayments.com).
4. I acknowledge below that I have not taken a “driving safety course” within one year immediately preceding the date of the alleged offense to have a citation dismissed in any court in Texas or in any other state. I am not currently in the process of taking a driving safety course, nor have I completed a driving safety course to have a citation dismissed that is not yet reflected on my driving record.
5. I have ninety (90) calendar days from the date the Interim Judgment is signed to complete a driving safety course that is approved **by the Texas Department of Licensing and Regulation (TDLR)** or, if operating a motorcycle, a motorcycle operator’s training course approved by the Department of Public Safety, and must **return to the Court the signed, original “Court” copy of the certificate of completion**. I understand that the driving school will charge a fee for the course. Under state law no extensions can be granted to take the course.
6. I am responsible for submitting to the Court a certified copy of my driving record from the Department of Public Safety. I may request my certified driving record online at <http://www.dps.texas.gov/DriverLicense/driverrecords.htm> by selecting the **3A Certified version** on the application for driving record. (NOTE: this should be ordered immediately, you do not need to have your driving record before you take the driving safety course.)  
**Military:** I am on active military duty or a spouse or dependent child of a member on active military duty, and I am responsible for requesting a certified copy of my driving record, if any, from the Department of Public Safety of the Licensing state.
7. When I have complied with the “Interim Judgment and Order to Comply,” the Court will dismiss my traffic citation and a record of attendance will appear on my driving record.
8. If I fail to comply with all requirements on the “Interim Judgment and Order to Comply” by the due date on that document, the Court will require my appearance at a show cause hearing as to why the Interim Judgment should not be revoked. If I fail to appear at the show cause hearing, a final conviction will be entered against me, a judgment will be rendered, and I will be required to pay the assessed fine and any additional costs required by law. If I am not eligible for a mandatory driving safety course a final conviction will be entered and I will be required to pay the amount stated in the Interim Judgment.
