- **Failure to submit ALL required documents and make payment by April 19, 2024 will forfeit your spot for this event.**

**Entry and set up** will be between 11:30 a.m. – 12:30 p.m. on Sunday, May 5, 2024.

- Certificate of Insurance (City of Corpus Christi as Additionally Insured)
- Copy of Current Vendor Permit
- Current Auto Insurance Card
- Attach Menu of Food Items
- 4 Color Photos of Food Truck/Trailer (front, rear, left, and right sides)

Out of county food truck vendors who do not have a Nueces County Health and Vendor permit will need to contact Environmental Health Services for a temporary special event permit.
