# After Hour Kid Power

The **"After Hour Kid Power"** program plans to reopen with the Corpus Christi ISD and Calallen ISD school calendar starting September 8, 2020.

**LICENSED PROGRAM:** "After Hour Kid Power" program is licensed by the Texas Health and Human Services.

**COVID-19 SCREENING PROCEDURE:** At a school-specified designated entry point, children and staff will be screened for fever or signs of COVID-19 illness prior to being permitted to enter the program site. If your child shows symptoms or has a fever, we will isolate him/her from our program. The parent will be contacted and required to pick up their child within 30 minutes to avoid exposure risk to others.

**NEW PICK-UP PROCEDURE:** At this time, we will not allow parents into the facilities for pick-up. Please call the phone number of the program site where your child is registered to pick up your child.

**MASK REQUIREMENT:** All staff and children are required to wear face mask and staff will encourage that children practice social distancing of 6 feet or more when applicable.

**NOTIFICATION PROCESS:** Should a child or staff member test positive for COVID-19, the **"After Hour Kid Power"** program will send out notice to all families within 48 hours of notification of a positive test. We follow your school district's flowchart for COVID-19 and/or refer to the local health department for additional guidance about returning to the program.

**UPDATED PARENT HANDBOOK:** Please take the time to review our updated Parent Handbook posted on our website as policies, fees, and procedures have changed.
